I. Introduction:

St. Thomas Aquinas Regional Catholic High School strives to continue to represent the Dominican traditions it was founded upon: prayer, community, study, and **SERVICE**, and so our school has established a program to introduce a culture of service and community in a special way for our students based on the Works of Mercy and the principles of Catholic Social Teaching. According to the Catechism of the Catholic Church, “The works of mercy are charitable actions by which we come to the aid of our neighbor in his spiritual and bodily necessities.” (CCC 2447) The Spiritual Works of Mercy include things like instructing, advising, consoling, comforting, forgiving, and bearing wrongs patiently. On the other hand, the Corporal Works of Mercy are more hands-on: feeding the hungry, sheltering the homeless, clothing the naked, visiting the sick and imprisoned, and burying the dead. The Principles of Catholic Social Teaching are a summation of the writings of the Church Magisterium in the modern age that tell us how we, as Christians, should live morally in our society-- with care for the dignity of the human person at all stages of life and of any

background or circumstance. These teachings tell us to put the poor and vulnerable first, to care for God's creation and be good stewards, to care for the dignity of all workers, to promote family values, and to recognize our obligation and responsibility to care for our community not from a distance but as brothers and sisters in Christ. These are all ways we are called to be a reflection of who God is and serve others as Christians in today's world.

III. Acceptable Service Hours

- Direct service to those who are in nursing homes.
- Serving neighbors will count for a maximum of 3 hours.
(example: yard work, babysitting, etc.)

- Attendance at the March for Life in Washington DC with STA Campus Ministry will count for 10 hours.
- Attendance at the March for Life in Louisiana (Baton Rouge) will count for 3 Hours.
- Attendance at a Pro Life Rally with the Knights of Columbus will count for 1 hour for each time attended. (Rallies are held the 1st Wednesday of each month).
- Summer Mission Trips. These hours require **mandatory** verification by the theology teacher.
- Serving as an Athletic Team Manager will count for 10 hours.

IV. Unacceptable Service Hours

- You may NOT receive hours for volunteering at a for-profit business. (ex. You may not file papers at a lawyers office.)
- You may NOT receive compensation for your service for it to count as service.
- May NOT be hours of service performed for family members.
 - While we encourage you to love and serve your family as much as you can, there is no concrete way for us to verify this.
- You may not complete the service hours during school.
- May NOT be hours related to political campaigning.
- Services performed when you are required to be present as a part of your sports team. (example: retrieving balls, line judges, setting up water coolers, etc.)

V. Documentation:

- **AFTER SERVICE:** Letterhead documentation with description of service and number of hours from the organization where the service was performed.
 - The service will not be accepted if it is not turned in within **two WEEKS** of the time of service with the exception of summer service hours. **All summer service hours are due August 20, 2025.**
 - Only hard copies of service hour forms will be accepted. (Documents can be printed from the STA website or will be available from your theology teacher)
 - Documentation **MAY NOT** be signed by **family members!**

VI. Deadlines:

- For **Seniors and 8th graders**, the last day to turn in service hours to your Theology Teacher is Tuesday, April 14, 2026.
- For **all other students**, the last day to turn in service hours to your Theology Teacher is Tuesday, May 5, 2026.

VII. Consequences:

- Students who have not met the requirements by May 5, 2026 (or April 14, 2026 for Seniors and 8th graders) will have their fourth quarter Theology grade lowered by up to ONE letter grade.

VIII. Recognition/Service Awards:

- **All Grade Levels:**
 - **Bronze Service Award**-- 10 hours ABOVE service requirement
 - **Silver Service Award**-- 25 hours ABOVE service requirement
 - **Golden Service Award**-- 50 hours ABOVE service requirement
 - **Falcon Servant Leadership Award**-- Awarded to the student with the most service hours in each grade level for that year.

- **Seniors:**
 - All Awards Above
 - **St. Teresa of Calcutta Award**-- Awarded to the student with the most service hours from their High School career.
 - Students that receive 150 hours for service for their High School career are eligible to receive a service cord. (If eligible, cords are purchased by students.)
